Terms and conditions

CANCELLATION POLICY: If for an unforeseen reason you have to cancel the following will apply:

- The first instalment is non-refundable under any circumstances.
- If you are paying by 5 monthly instalments, all previous payments at the time of cancellation will not be refundable
- If you have paid the full amount up front any refunds will be calculated by Cameron.

Please note, if the first instalment is not paid by 20th October there is \$150 fee (if discussed with Cameron Prior to this date this fee may be waived). Cam's Cycle Coaching will decide at its own discretion if a refund will apply if you cancel and your position can be replaced.

TRAVEL INSURANCE: It is a company policy of Cam's Cycle Coaching that all clients travelling with us have adequate travel insurance covering accident, personal injury, bicycle, bicycle damage, loss of luggage and cancellation.

ALTERATIONS: Cam's Cycle Coaching reserve the right at any time to substitute alternative accommodation or to make any other alteration to the tours which become necessary due to circumstances beyond their control and undertake to inform participants as soon as possible.
